**ELIGIBILITY FOR DISTRICT XI GOLF TOURNAMENT**

- A. To be recognized, a league must include at least five District XI teams.
- B. 2017 District XI Qualifier Exemptions (move directly to the District XI Championship):
  - 1. Boys Individuals- any players who played in the PIAA State Individual Championship the year before. The top 5 & Ties for individuals based on their finish in their League Championship Tournament (DXI Golfers).
  - 2. Girls Individuals- Any players who played in the PIAA State Individual Championship the year before. Top 2 & Ties for individuals based on their finish in their League Championship Tournament (with a score of 110 or lower) – (DXI Golfers).
- A. Qualifying Round – Boys:
  - a. Average scores will range from 78 to 85 depending on course slope. Averages will now be based on all rounds played during the regular season. Player's high scores will no longer be dropped. An entry form will be sent to all District XI schools electronically and returned to the Tournament Director.

Qualifying Round - Girls: Coaches Recommendation, if a coach feels a girl can shoot a 110 on a championship course, she will be allowed to play in the district qualifier on the coach's recommendation.

- b. Schools that do not have a golf team will be entitled to participate only if the golfer has a USGA handicap with an index of 10.0 or below, a copy of which must accompany the entry form to the tournament director.
- B. District XI Championship Round
  - a. Girls – need a qualifying score of 110 to advance to the district championship.
  - b. Boys – Top 50% of finishers advance in both AAA & AA from the qualifying round plus exemptions identified above.
- C. No participant will be allowed to participate unless accompanied by an employee of the school district.
- D. The individual and team deadline is: **Wednesday, September 27, 2017**. All regular season matches must be completed by this date. Schools are responsible for making sure they have competed in the required 9 PIAA competition's by the deadline. Schools that do not compete in the required 9 competitions by the deadline are

ineligible to participate in the DXI Tournament. Entries include Boys, Girls, and Exemptions. Entry forms will be sent to Robert Frey, Tournament Director, via fax or email.

- C. The District XI Golf Coaches Committee and Course Professional will meet with all scorers explaining their duties and responsibilities at 8:30 a.m. The golf coaches committee will serve as tournament marshals for all events.
- D. Tournament headquarters will be identified at the course.
- E. PIAA rules apply in accordance with conduct of players, coaches, and spectators; and authorization to use range finders.
- F. Final instructions, rules, and procedures for both tournaments will be reviewed with all participants at 8:45 a.m. sharp. Shotgun start will begin promptly at 9:00 a.m.
- G. The qualifying round and championship round will consist of 18 holes of stroke play.
- H. All contestants will be required to play the stated number of holes unless the tournament committee deems it impossible due to a delay.
- I. The qualifying score does not count toward the District XI Championship.
- J. At the conclusion of both the qualifying round and Championships, information will be provided to the coaches of the individuals who have qualified for the next round.

**ELIGIBILITY FOR DISTRICT XI TEAM GOLF CHAMPIONSHIP**

- A. 4 AAA and 4 AA Boys Teams will qualify for the Team Championship
- B. District XI league champions will automatically qualify for District XI Golf Championship. To be recognized, a league must include at least five District XI teams.
- C. A team must participate in 9 team competitions during the regular season to be eligible for post-season team competition.
- D. The District XI Power Rating system will be used to determine the other qualifiers to complete the field. The top 4 teams in each classification will compete for the DXI Team Championship.
- E. The last day of competition that counts toward qualification is September 27, 2017.

**GAME REGULATIONS**

- A. Dress code applies to all participants and coaches.
- B. USGA Rules will be enforced.
- C. Tournament headquarters will be identified at the course.
- D. PIAA rules apply in accordance with conduct of players, coaches, and spectators; and authorization to use range finders.
- E. All qualifying teams will send 5 players. They will be paired with members of the other teams in an 18 hole stroke play match. The top four scores for each team will count for team score.
- F. The team with the least number of strokes in each classification will be declared the champion. In the event of a tie, the number one player of the tied teams will play a sudden victory playoff to determine a winner. The order of holes will be designated the day of the event.
