## Complimentary Ticket Language

Effective, <u>January 2022</u>, PIAA District XI will no longer issue Playoff Event Complimentary Tickets per event.

At the beginning of each school year, a maximum of six (6) total passes, including Principal and Athletic Director passes, will be issued to each High School. These passes will be good for the entire school year.

Member schools may distribute these passes at their discretion. Passes are transferable and member schools may issue and recollect these passes on a per event basis if they so choose.

For sub-regional events, digital complimentary tickets will be provided to each non-District XI school per event.
