2023-24 Recommendations

- 1. Remove Resignation/Retirement Consultant Stipulation.
- 2. Female Sports Representative must be employed by a DXI school that offers female DXI sports.
- 3. Parent Representative must have a student-athlete participating at a DXI school in a DXI sport in grades 7-12.
- 4. Superintendent Representative must be employed as a Superintendent at a DXI school offering Sports through DXI in grades 7-12.
- 5. Junior High Representative must be employed by a DXI school that offers Junior High/Middle School sports through DXI.
- 6. Private School Representative must be employed at a Private School in DXI offering DXI sports.
- 7. Beginning in the 2024-25 school year, the 2-year Athletic Director Association Representative will be converted into a Gender & Minority Equity Representative. This representative must be employed by a DXI school as a school administrator and a member of an underrepresented group. The position will remain a 2-year term, determined by the DXI Committee.
