### **District XI Financial Reimbursement Policy**

Proposal 8-13-23

- 1. All home teams will receive reimbursement on the following scale, when hosting a playoff contest. Reimbursement will be paid at the end of each sports season.
  - a. \$250 Baseball, Field Hockey, Lacrosse, Soccer, Softball, Volleyball
  - b. \$450 Basketball
  - c. \$1000 1A Football
  - d. \$1500 2A Football
  - e. \$2300 3A Football
  - f. \$3100 4A Football
  - g. \$4000 5A, 6A Football
- 2. Revenues from item #1 will be distributed at the end of each season.
- 3. Profit sharing revenue will be shared at the end of the fiscal year based on the District XI threshold established each August. All remaining dollars over the threshold will be disseminated to schools based on the following:
  - a. School must be a member high school in good standing
  - b. Member high school must sponsor one of its own varsity sports
    - i. Co-operative sponsorships only do not qualify
  - c. School must qualify to have its dues paid for by District XI and follow all components that allow for that
  - d. No reimbursement will be given if District XI does not meet the financial threshold.
