**ELIGIBILITY FOR CROSS COUNTRY:** Each school may enter six (6) persons plus alternates (or fewer). Five (5) runners must finish the race for the score to count as a team score.

- A coach or a faculty member must accompany all entrants from that school.
- Entries must be submitted online via e-mail to Bryan Geist on or before **Thursday, October 22, 2020, by 12 noon.**

**FINANCES:** Reimbursement and expenses will be paid in accordance with District XI Policy.

**ASSIGNMENT OF OFFICIALS:** The District XI Officials Representative will assign Officials.

**SPORTSMANSHIP STATEMENT:** PIAA requires all registered sports' officials to enforce the sportsmanship rules for coaches and contestants. Actions meant to demean opposing contestants, teams, spectators and officials are not in the highest ideals of interscholastic education and will not be tolerated. Let all contests reflect mutual respect. Coaches will certify prior to the contest that teams are legally equipped according to the rules of that contest.

**COURSE INFORMATION:** Grass, cinders and macadam.

**UNIFORM RESTRICTIONS:** School issued uniforms only.

**CHAMPIONSHIP SCORING:** The first five persons of each team will be scored. The sixth person will be tallied and may displace members of other teams finishing later. Your school's starting position will be pre-drawn. A bib system will be used with the results posted to the DXI website. Tabs will be pulled and a video camera will be used for scoring.

**PARKING:** Designated parking areas will be made available to participating schools for buses and/or vans.
