WHO IS ELIGIBLE TO COMPETE:

- A. All teams must qualify by winning at least 50% of their league games or 50% of their overall schedule. Ties do not count. League playoffs do not count.
- B. Independent teams must qualify by winning at least 50% of a minimum of nine regularly scheduled and contracted games.
- C. Cut-off date for entries: ***Saturday, October 24, 2020***
- D. A league must consist of at least five (5) District XI schools.
- E. Qualifiers determined by District XI Policy on qualification as seen in handbook
- F. Minimum Qualification by Class:
 - A – 6
 - AA – 4
 - AAA - 8

METHOD OF SEEDING:

- **District XI Power Rating System**
- League Champions will be seeded first.

TIEBREAKER: The District XI Power Rating system tiebreaking procedure will be used to break seeding ties.

GAME LOCATIONS:

Top seeded team will have home field in the pigtail and first round.
Semi-Final and Final Locations will be determined by the District Committee – (TBA in District XI)

FINANCES: Reimbursement and expenses will be paid in accordance with District XI Policy.

ASSIGNMENT OF OFFICIALS: Referees will be assigned by the District XI Female Officials Representative. Referees for Field Hockey will be paid by the District at the conclusion of the tournament.

SPORTSMANSHIP STATEMENT: PIAA requires all registered sports' officials to enforce the sportsmanship rules for coaches and contestants. Actions meant to demean opposing contestants, teams, spectators and officials are not in the highest ideals of interscholastic education and will not be tolerated. Let all contests reflect mutual respect. Coaches will certify prior to the contest that teams are legally equipped according to the rules of that contest.
