The meeting is not mandatory but questions will only be addressed at that venue. All entries are final at the beginning of the meeting. The meeting will take place in the LGI at Whitehall High School. Please be prompt. Committee will finalize seeding on Wednesday, February 21, 2024. Brackets will be posted by 12:00 noon on Thursday, February 22, 2024.

ALL OTHER SEEDING INFORMATION WILL BE PULLED FROM THE NWCA WEB SITE. COACHES SHOULD CHECK THE NWCA WEB SITE FOR ACCURACY PRIOR TO 9:00 A.M. **TUESDAY, FEBRUARY 20, 2024.** NO CHANGES, SUBSTITUTIONS, OR ADDITIONS CAN BE MADE AFTER THE BEGINNING OF EACH RESPECTIVE SEEDING MEETING.

This information is tentative, and changes can be made up to the start of the your respective verification meeting. Once seeding is complete brackets will be re-seeded until the close of weigh-ins, at which point all removals of wrestlers will be forfeits.

NOTES: (a) A team forfeit (e.g., strike) does not count in an individual wrestler's record. An individual forfeit does count.

(b) Certified weights on eligibility sheets must be for specific weight classes.

(c) All wrestlers will be seeded.

(d) There is no such thing as a medical forfeit in high school wrestling. Any match that should have been contested has a result.

### **Number Advancing to Regionals in AAA**

Five (5) wrestlers will advance to the Regionals.

Reminder, NE AAA Regionals will be fourteen (14) wrestlers per weight class.

### **Number Advancing to Regionals in AA**

Four (4) wrestlers will advance to the Regionals.

Reminder, SE AA Regionals will be twelve (12) wrestlers per weight class.

Explanation - Criterion #1 - Percentage record of this season's Varsity dual meet bouts and tournament bouts. Based on total won/loss record.

\*\*\*\*\* Points: 1 point for win

\* W-L in Team \* Divide: Points scored by total bouts  
\* Districts & \*

\* will not \* Example: 15 - 5                       $15 \div 20 = 75$

**Must have 12 bouts minimum to get full total. if not, subtract 8 points for each bout under 12 from the total.**

Example: 6 - 2                       $6 \div 8 = 75 - 32 = 43$

NOTE: Always round out to two decimal points.

- NOTE:**
1. A sectional champion in a district which is region unto itself (district 1, 3, 7) shall be equivalent of a district place-winner in the chart above.

  3. For purposes of validation, documentation must be brought to the verification meeting for all of your wrestlers' opponents who have out-of-state credentials. Out-of-state points will not be awarded without proper validation
